Safety Committee member Nicole Townsend presented bids for courthouse panic buttons from SecureTech and Applied Connective Technologies. Kelly Lehmann was also present. Following discussion, motion by Lerdall, seconded by Hofman, to accept the bid from Applied Connective Technologies in the amount of \$20,083.00 with an annual service fee of \$3,250.00. Asst. Hwy. Supt. Kelly Lehmann was present and provided a road report. Road employees have completed the rebuild project on Rd 737 east of Rd 420 and are currently working on Rd 420 and Rd 738 to address excess water flowing over the roadway. The damaged guardrail on the Dam Road at Johnson Lake, caused by a vehicle accident, has been repaired.

The Board approved two Applications for Permit to Construct on County ROW for Great Plains Communications and Consolidated Companies, Inc.

Motion by Hofman, seconded by Lerdall to allow \$500.00 from the Keno/Lottery Fund to the Elwood Pirates/Hi Line Booster Club. Roll Call Vote: "Aye" Lerdall, Bader, Hofman, motion carried.

Motion by Lerdall, seconded by Hofman to convene as the **Board of Equalization**. Roll Call Vote: "Aye" Lerdall, Hofman, Bader, motion carried. Assessor Pam Bogle was present and submitted a Tax List Correction. Motion by Bader, seconded by Lerdall to approve Tax List Correction #1044. Roll Call Vote: "Aye" Lerdall, Hofman, Bader, motion carried. Motion by Bader, seconded by Hofman to adjourn as the **Board of Equalization**. Roll Call Vote: "Aye" Lerdall, Hofman, Bader, motion carried.

The Board reviewed the FY 2025-26 budget request from Region II Human Service Behavioral Health. Motion by Hofman, seconded by Lerdall to approve Gosper County's assessment for FY 2025-2026 in the amount of \$8,272.38. Roll Call Vote: "Aye" Lerdall, Hofman, Bader, motion carried.

The Board received a Membership Assessment Statement from West Central Nebraska Development District for annual dues and membership. Motion by Lerdall, seconded by Hofman to not become a member. Roll Call Vote: "Aye" Lerdall, Bader, Hofman, motion carried.

Motion by Bader, seconded by Lerdall to approve the County Annual Certification of Program Compliance and **Resolution No. 25-7** from the NE Board of Public Roads. Roll Call Vote: "Aye" Lerdall, Bader, Hofman, motion carried.

Clerk Karen Corder requested authorization to obtain a credit card through Pinnacle Bank for official county use. Motion by Bader, seconded by Hofman to approve the issuance of a credit card through Pinnacle Bank to Clerk Corder.

Clerk Corder and Treasurer Townsend were present to review the FY2025-2026 budget expenditures and revenues. The Board reviewed the budget requests submitted by the officials and department heads. Asst. Hwy Supt. Kelly Lehmann and Sheriff Joshua Richie were present.

The Board noted that Nebraska Supreme Court Chief Justice Jeffrey Funke and Associate Justices will visit the courthouse to meet with the court community on August 13th, 2025.
