They explained that the system is internet-based and serves as an alternative to traditional phone lines. They reported that it offers higher reliability, lower cost, and additional features not typically available from other providers. Following discussion, motion by Bader, seconded by Lerdall to switch to Applied Connective for the Courthouse phone system. Roll Call Vote: "Aye" Lerdall, Bader, Hofman, motion carried.

County Attorney Beverly Louthan, Treasurer Niki Townsend, Assessor Pam Bogle and Clerk Corder were present to discuss setting the salaries for elected county officials for the 2027-2030 term of office. Assistant Highway Superintendent Kelly Lehmann was also present. The Board reviewed the recommendations from the Nebraska Association of County Officials salary committee, which recommends a benchmark salary range of \$73,084.00 to \$77,138.00 for county officials. Discussion was held. No action was taken.

Motion by Lerdall, seconded by Bader to convene as the **Board of Equalization**. Roll Call Vote: "Aye" Lerdall, Bader, Hofman; motion carried. Motion by Bader and seconded by Hofman to approve the Motor Vehicle Tax Exemption renewal as indicated on the application by County Treasurer Townsend for Community Action Partnership of Mid-Nebraska for a 2017 Dodge Wagon and 2018 Dodge Caravan. Roll Call Vote: "Aye" Lerdall, Bader, Hofman, motion carried. Motion by Lerdall, seconded by Hofman, to adjourn as the Board of Equalization. Roll Call Vote: "Aye" Lerdall, Bader, Hofman, motion carried.

The Board reviewed a letter from NIRMA regarding an upcoming Board vacancy.

Motion by Bader, seconded by Hofman, to authorize Chairman Lerdall to sign a letter of authorization to prior auditor Donald Wilson. Roll Call Vote: "Aye" Lerdall, Bader, Hofman, motion carried.

Assistant Highway Superintendent Kelly Lehmann was present to give a road report. He reported that the Johnson Lake Inlet Bridge was closed on November 15, 2025. Serious deterioration of the structure's pilings had been found since the previous inspection in December 2024. The Bridge no longer met the minimum federal load limit standard of 3 tons, requiring immediate closure. Road employees installed permanent barricades and cement bunkers at both ends of the bridge, along with 'Bridge Closed' and 'Road Closed Ahead' signage and hazard lights.
