

A meeting of the Gosper County Board of Commissioners was convened in an open and public session at 9:00 a.m. on June 10, 2026, at the Gosper County Courthouse, Elwood, Nebraska. Present were Chairperson Terry Lerdall and Members Bruce Bader and Glenn Hofman. Clerk Karen Corder was present to record the proceedings. County Attorney Beverly B. Louthan was present.

Public notice of this meeting was published in the Valley Voice, posted on the Gosper County Website, and on the Courthouse bulletin board on May 28, 2026. The published notice included information regarding the availability of the agenda. All proceedings of the Board were conducted during a duly convened meeting open to the public.

The meeting was duly called to order and Chairman Lerdall announced and informed the public that a current copy of the Nebraska Open Meetings Act is posted on the wall of the meeting room.

The Minutes of May 27, 2026 meeting were read. Motion by Hofman, seconded by Lerdall to approve the minutes as read. Roll Call Vote: "Aye" Lerdall, Bader, Hofman, motion carried.

Motion by Bader, seconded by Hofman, to approve the Clerk of District Court report for the month of May. Roll Call Vote: "Aye" Lerdall, Bader, Hofman, motion carried.

Roger Powell, Emergency Manager, provide an update on the Local Emergency Operations Plan and presented **Resolution 26-7**. Motion by Lerdall, seconded by Bader, to approve **Resolution 26-7** adopting the 2026 Local Emergency Operations Plan which provides for a coordinated response to disasters and emergencies in Gosper County and the Villages of Elwood and Smithfield. Roll Call Vote: "Aye" Lerdall, "Aye" Bader, "Nay" Hofman, motion carried.

County Attorney Louthan presented the Driver's Safety Training Program Application for Program Certification Approval for the S.T.O.P. Class and provided a signed copy to the Board for review.

At 10:00 a.m., Motion by Lerdall, seconded by Bader, to convene as the **BOARD OF EQUALIZATION**. Roll Call Vote: "Aye" Lerdall, Bader, Hofman, motion carried. Assessor Pam Bogle was present, and the Judiciary notice was read. The Board reviewed the Personal Property Schedules. Motion by Lerdall, seconded by Bader, to recess as the BOARD OF EQUALIZATION until June 30, 2026 at 1:00 p.m. Roll Call Vote: "Aye" Lerdall, Bader, Hofman, motion carried.

Highway Superintendent Kelly Lehmann was present and gave a road report.

Motion by Hofman, seconded by Bader, to approve the renewal billing statement from NIRMA/NIRMA II for the policy period of July 1, 2026, through July 1, 2027. Roll Call Vote: "Aye" Lerdall, Bader, Hofman, motion carried.

Motion by Bader, seconded by Hofman to approve a Special Designated Liquor License for Crazy Marv's RV & Cabin Retreat, LLC for an event on July 11, 2026. Roll Call Vote: "Aye" Lerdall, Bader, Hofman, motion carried.

The Board reviewed correspondence from The Village of Elwood and Region II Services. The Board adjourned at 11:30 a.m.
